**LOVE FOR MARINE LIFE COMPREHENSIVE SCHOOL PROGRAM FOR  
SCHOOL YEAR 2017-2018 OF THE MARYLINDBERT INTERNATIONAL**

The MaryLindbert International, in partnership with the Manila Ocean Park, announces the implementation of its *Love for Marine Life Comprehensive School Program for School Year 2017-2018*.

The Program aims to:

1. advocate awareness, proper care and education on marine flora and fauna of the Philippines;
2. provide venues for learners and their families to learn more about the diverse creatures under the sea; and
3. provide an avenue for the learners to understand their part in taking care of the marine life and to help in its conservation and propagation.

Learners and teachers from both public and private elementary and secondary schools as well as interested individuals may visit the Manila Ocean Park. It should be noted that excursions to venues outside school premises may not be organized or sanctioned by elementary and secondary schools at this time in line with DepEd Memorandum No. 47, s. 2017 entitled *Moratorium on DepEd Educational Field Trips and Other Similar Activities* to ensure the security and safety of learners. Such visits may be made by learners and teachers outside of school hours, and only in their individual capacity.

Participation of both public and private schools shall be subject to the *no-disruption-of-classes policy* stipulated in DepEd Order No. 9, s. 2005 entitled *Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith*.
