OF THE PHILIPPINES–BAGUIO, CORDILLERA STUDIES CENTER

The University of the Philippines–Baguio (UPB), through its Cordillera Studies Center (CSC), will hold its *2nd International Conference on Cordillera Studies* with the theme *Indigenous Studies in the Philippines: Issues and Prospects* from July 12 to 14, 2017 at the CAP John Hay Trade and Culture Center, Baguio City.

The Conference aims to:

1. promote debate and identify directions on how Indigenous Studies, as a distinct field of inquiry, can be established and consolidated in the Philippines; and
2. foster collaborative work between academics, local and national government agencies, civil society, and communities in the Cordillera, Northern Luzon, and the Philippines.

The target participants are teachers who are involved in Indigenous Peoples Education and related DepEd programs in the Philippines.
