- a. That we shall finish the course and comply with all the requirements prescribed by the SEAMEO INNOTECH, including the Revalida (revalidation) at SEAMEO in Diliman, Quezon City.
- b. That after having successfully completed the course, we shall submit to the DepEd Regional Office III a certified/validated photocopy of the Certificate of Completion/Competence with a rating of "A" or "B";
- c. That in the event we fall short of the course requirements or fail to finish the course, through our fault or willful neglect, resignation from the service, transfer to other agencies, voluntary retirement or other causes within our control, we shall be obliged to refund all financial support provided by the DepEd RO3 as sponsoring agency; and
- d. That after completion of the GURO21 scholarship grant, we shall render the compulsory service obligation as public school teachers in accordance with the Civil Service Commission (CSC) MC No. 44, s. 1992, equivalent to the period of scholarship indicated as follows:
  - Duration: a fraction of a year not 1 year exceeding six (6) months, but not less than two(2) months
  - Service Obligation: one (1) year
