### **PALARONG PAMBANSA 2015**

1. The 2015 **Palarong Pambansa** will be held from May 3 to 9, 2015 at the Davao del Norte Sports and Tourism Complex, Tagum City to be hosted by the Provincial Government of Davao del Norte and the Department of Education Regional Office XI to be assisted by the Schools Division Office of Davao del Norte.
2. The Central Luzon Regional Delegation will be billeted at Panabo National High School, Panabo City, Davao del Norte.
3. Prior to our participation in the said national meet, there will be a centralized training of athletes to be conducted at Zambales Sports Complex, Iba, Zambales. The training for Volleyball EB/SG will be at Holy Family Academy covered court on April 7 to 26, 2015.
4. Departure for Panabo City will be on April 28, 2015. The Angeles City Delegation will assemble at DepEd Regional office (*to be announced later*).
5. Coaches, Asst. Coaches, Chaperons, and Trainers should at all times uphold the Loco-Parenti Principle (*in place of a parent*). They should provide adequate supervision on athletes and ensure the development of athletes on discipline,

honesty, cleanliness and orderliness, sportsmanship and camaraderie (RM 194 s.2014).

6. Participants are advised to bring their own beddings, toiletries and flashlights.
7. Service Credits shall be granted to teacher-coaches/chaperons/trainers, and officials who will serve during the training and in the Palarong Pambansa as stipulated in DECS Order No. 53 s.2003.
8. Enclosed herewith is the list of Angeles City Delegation.
9. Expenses during the conduct of training and participation in the 2015 Palarong Pambansa such as meal allowances of athletes, coaches, chaperons, trainers and officials and other related expenditures shall be charged to local SEF funds subject to the usual accounting and auditing procedures.
10. Immediate dissemination of this Memorandum is desired.

**2015 PALARONG PAMBANSA**

1. The **2015 Palarong Pambansa** will be held from May 3 to 9, 2015 at the Davao del Norte Sports and Tourism Complex, Tagum City to be hosted by the Provincial Government of Davao del Norte and the Department of Education (DepEd) Regional Office XI to be assisted by the Schools Division Office (SDO) of Davao del Norte.
2. The National Executive Committee, chaired by the Undersecretary for Regional Operations, together with the Local Host *Palaro* Executive Committee led by the Governor of the Provincial Government of Davao del Norte as Chairman, and the DepEd Region XI Director as Co-Chairman, together with the Host Schools Division Superintendents (SDSs), is hereby convened.
3. The DepEd regional offices (ROs) shall organize their respective athletic delegation comprising the best student-athletes, coaches and officials.
4. The technical management, as well as the financial, administrative and operational matters relative to the preparations, hosting and conduct of the *Palarong Pambansa* shall be under the Office of the Assistant Secretary for Legal and Legislative Affairs to be assisted by the School Sports Events and Activities Unit (SSEAU). The SSEAU shall provide the list of the technical management, secretarial/staff, and operational services.
5. The sports events played in the previous 2014 *Palarong Pambansa* with its related general and technical guidelines shall remain in effect unless otherwise amended, modified or revised.
6. Pursuant to the provisions under Republic Act (RA) No. 10588, otherwise known as *Palarong Pambansa Act of 2013*, the following guidelines are hereby adopted:
  - a. *Futsal*, Billiard, *Wushu* and Wrestling shall be played and remain as demonstration sports. The winners shall be awarded with medals; however, the same shall have no merit in the count of the participating regions;

- b. *Sipa Takraw* in the elementary division shall be renamed as *Sepak Takraw Jr.* The rules in *Sepak Takraw* shall be applied. *Sepak Takraw* for girls shall be added in the secondary level, but it will remain as demonstration event.
7. Enclosed is the list of the team composition and sports events to be played.
8. The Clean, and Green and Eco-Friendly Policy which is being implemented during the *Palarong Pambansa* shall be enjoined and adhered to.
9. Immediate dissemination of this Memorandum is desired.
