LRMDS PORTAL REGISTRATION OF ALL DEPED PERSONNELS

(Re-iteration of DepEd Order No. 76 s.2011 - National Adoption And

Implementation of the LRMDS)

- The Department of Education (DepEd) advocates the adoption and implementation of the Learning Resources Management and Development System (LRMDS) pursuant to the implementing rules and regulations of Republic Act No. 9155 and to support the organization of Key Reform Thrust (KRT) 3 of the Basic Education Sector Reform Agenda (BESRA).
- 2. The LRMDS Framework serves as the policy instrument for the implementation and ongoing operation of LRMDS at all levels of DepEd. It is supported by guidelines and process documents for all sub-systems, a quality assurance framework, standards and specifications (e.g., educational, technical, intellectual property rights, accessibility, metadata), and training programs.
- 3. The LRMDS is a web-based catalogue and on-line repository of learning, teaching, and professional-development resources. It has four (4) integrated sub-systems, namely:
  - (i) assessment and evaluation; (ii) development, acquisition, and production; (lii) storage and maintenance; and (iv) publication and delivery which are designed to support increased distribution and access to learning, teaching, and professional-development resources at the regional, division, and school levels. It includes the following:
  - a. information on quantity, quality, and location of textbooks and supplementary materials, and other teaching-learning resources;
  - b. access to learning, teaching, and professional development resources in digital format; and
  - c. standards, specifications, and guidelines for four (4) subsystem.

- 4. The DepEd officials and field personnel are enjoined to register at <a href="http://lrmds.deped.gov.ph/register/">http://lrmds.deped.gov.ph/register/</a> in order to access the LRMDS portal. The registration is authenticated within twenty-four (24) hours.
- 5. The use of non-deped email (deped.gov.ph) in the registration of portal access is highly discouraged.
- 6. Newly hired teachers need to register through the usual process:
  - a. Sign up through <a href="http://lrmds.deped.gov.ph/register/">http://lrmds.deped.gov.ph/register/</a> (make sure to fill in completely including the "Division" required field).
  - b. Open gmail.com through your deped email and look for the activation email sent by LRMDS and click "activate" to activate your lrmds account.
  - c. If no activation link was sent to your deped email, please check if the registered email used is spelled correctly, otherwise report the issue to the school LRMDS Coordinator to escalate it to the PDO II-LRMDS for proper trouble shooting.
- 7. For LRMDS account users who already have active access to the portal, please update your account profile by logging in to your account and fill in appropriate information through <a href="http://lrmds.deped.gov.ph/user/profile/">http://lrmds.deped.gov.ph/user/profile/</a>.
- 8. For LRMDS account users who forgot their passwords; you may request for a password reset through <a href="http://lrmds.deped.gov.ph/resetting/request">http://lrmds.deped.gov.ph/resetting/request</a>. Input the email account you used to register in the portal, check the captcha box (I'm not a robot) and click reset password. A link will be sent to your DepEd Email to process a reset.
- 9. An accomplishment report is highly required to be submitted in hard copies and through google sheet/drive. Reports should be prepared by the School Learning Resource Coordinator and must be noted by the school head. The Google doc links per school is attached for your completion. The assigned link should be available by signing in to your DepEd email account.
- 10. Completion of school personnel LRMDS Registration is until October 15, 2016. Deadline of submission of Registration Report is on October 19, 2016. A certificate of submission will be given to LRMDS Coordinator and School upon submission.
