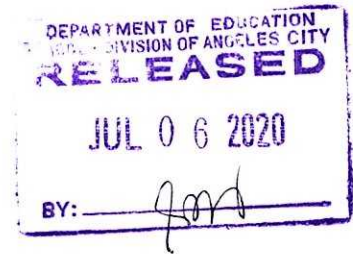

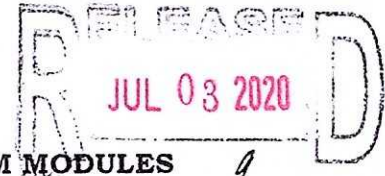

**REGIONAL CONTEXTUALIZATION OF K - 3 ADM MODULES

1. The Department of Education (DepEd) Region III announces the Regional Contextualization of ADM Modules for Kapampangan and Sambal Languages through the Curriculum and Learning Management Division (CLMD) and Learning Resource Management Section (LRMS) on **July 7-27, 2020**. The Online Orientation of the participants shall be held on **July 7, 2020, at 8:30 a.m.**
2. The activity aims to contextualize the K to 3 Alternative Delivery Mode (ADM) Modules for Kapampangan and Sambal Languages.
3. The participants to the activity are the contextualizers, illustrators, layout artists, language reviewers, content editors, and the quality assurance team.
4. As stipulated in DepEd Order No. 53, s. 2003, re: *Updated Guidelines on Grant of Vacation Service Credits to Teachers, provision 1, item d, sub-item k, service credits may be granted to all teachers who attended/participated in special DepEd projects and activities which are short-term in duration such as English, Science and Math Mentors' Training, curriculum writing workshop, planning workshop, etc., if such are held during the summer vacation or during weekends*. On the other hand, non-teaching staff shall be provided with Compensatory Time-Off (CTO) per Civil Service Commission (CSC) and Department of Budget and Management (DBM) Joint Circular No. 2, s. 2004 on *Non-Monetary Remuneration for Overtime Service Rendered*. Hence, teachers who are involved in this activity will be given service credits while the non-teaching participants shall earn Compensatory Day/Time Off (CTO) in lieu of July 11 and 12, 2020 (Saturday and Sunday).
5. The deadline for the submission of contextualized K-3 ADM Modules shall be on **July 28, 2020**, at email add ncstor.nuesca@deped.gov.ph cc: maeditha.capas@deped.gov.ph, and librada.rubio@deped.gov.ph.
