To: Assistant Schools Division Superintendent Chief ES, SGOD OIC-Chief ES, CID Public Elementary and Secondary School Heads

1. Pursuant to DepEd Order No. 027, s. 2019 entitled 'Guidelines on the Yearly Collection of Data/Information Requirements and validation Processes, which directed all public and private elementary, junior, and senior high schools, state universities and colleges (SUCs), and higher education institutions (HEIs) offering Kindergarten to Grade 12 to update the school's profile and report other data elements in the BEIS through the accomplished data gathering forms.
