Description

PRINTING SERVICES FOR THE PROVISION OF EPP, TLE & SENIOR LEARNING RECOURCES FOR QUARTERS 3 & 4 OF SY 2020-2021

1. The Department of Education- Schools Division of Angeles City, through part of the FY 2021 GAA SUB-ARO Order No. DEPED-ROIII-2021-03-055 dated March 1, 2021 intends to apply the sum of Six Million One Hundred Forty Nine Thousand Three Hundred Twenty Nine Pesos only (Php 6,149,329.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Printing Services for the Provision of EPP, TLE & Senior Learning Resources for Quarters 3 & 4 of SY 2020-2021. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Department of Education- Schools Division of Angeles City, now invites bids for Printing Services for the Provision of EPP, TLE & Senior Learning Resources for Quarters 3 & 4 of SY 2020-2021. Delivery of the Goods is required to be completed on May 17, 2021 within 45 days after the issuance of Notice of Award. Bidders should have completed, within 45 days from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

(i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty

percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. A complete set of Bidding Documents may be acquired by interested bidders every Monday, Tuesday, Wednesday and Friday, 8:00a.m.-5:00p.m. and every Thursday from 8:00am to 3:00pm only from March 24, 2021 – April 12, 2021 at Jesus Street, Pulungbulu, Angeles City, and upon payment of the non-refundable fee, pursuant to the latest Guidelines issued by the GPPB as stated below:

6. The Department of Education, Schools Division of Angeles will hold a Virtual Pre-Bid Conference on March 26, 2021, 10:00 a.m. through Google Meet Platform.

7. Bids must be duly received by the BAC Secretariat at the address below on or before April 12, 2021, 8:00-9:30 a.m.. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

The opening of bids will be online using Google Meet Platform on April 12, 2021, 10:00 a.m. through Google Meet Platform. Bids will be opened in the virtual presence of the bidders' representatives who choose to join in the online bidding.

The Department of Education- Schools Division of Angeles City reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
