It has been observed that some DepEd Angeles City Policies issued through different memoranda are being ignored and/or forgotten.

Again, please be reminded of the following policies:

- 1. Wearing of IDs IDs should always be worn at all times during office hours.
- 2. Presence during Flag Raising every Monday and Flag Retreat every Friday - All personnel are required to be in front of the flag pole before 7:45 a.m. (Flag Raising) and 4:45 p.m. (Flag Retreat) and should not wait for the ringing of the bell to signal the start of Flag Ceremonies.
- 3. Personnel who works during weekends (Saturday Sunday and holidays) - should ask permission from the Office of the Schools Division Superintendent since they are using government resources, except those activities sanctioned by this Office.
- 4. All Division Memoranda should pass through the School Governance and Operations Division (SGOD) - this is to avoid any conflict, overlapping and duplication in the dates/schedule and venue

5. Tardiness - please be reminded that the 15 minutes grace period provided under DepEd Order 31, s. 2014, "Implementation of the Flexi-Time Work Schedule for the Non-Academic Personnel of the Department of Education" does not supersede the Civil Service Commission (CSC) Memorandum Circular No. 34, s. 1998 relative to an amendment to Section 8, Rule XVII of the Omnibus Rules Implementing Book V of Executive Order No. 292 (Administrative Code of 1987), to avoid its abuse, which states that:

<u>SEC. 8</u>. Officers and employees who have incurred tardiness and under time, **regardless** of the number of minutes per day, ten (10) times a month for at least two (2) consecutive months during the year or for at least two (2) months in a semester shall be subject to disciplinary action.
