

### **Dear Director Garma:**

Greetings from the National Nutrition Council (NNC) Central Luzon!

The NNC Governing Board Resolution No. 6 approved the adoption of the 2012 Nutritional Guidelines for Filipinos (NGF) on 31 October 2012. The nutritional guidelines aim to address and prevent malnutrition and diet-related non-communicable diseases such as cancer, diabetes and cardiovascular diseases. The NNC GB resolution also instructed the NNC Secretariat to "spearhead the formulation and evaluation of a communication and promotion plan to ensure the widest dissemination and use of the 2012 Nutritional Guidelines for Filipinos and ensure participation of non-government organizations, media, the academe and civil society". Thus, NNC developed and popularized the NGF into 10 Kumainments, simple and easy to remember guidelines that can be easily followed by public elementary pupils to improve their nutritional status.

In support to this promotional activity, the NNC-region III will conduct an "Information Sharing Session on NGF-10 Kumainments among the elementary school children, school heads and teachers of selected public elementary schools of the seven provinces in Central Luzon. The activity aims to expand and enhance public awareness on the 10 Kumainments, particularly among school children, school heads and teachers. The information sharing session (ISS) will be dovetailed with the Launching of NGF on Wheels targeting selected members of the Tricycle Operators and Drivers Association (TODA) in selected municipalities of the seven provinces. We will initially start both ISS and launch of the NGF on Wheels in Aurora Province on 10 February 2017 and will move next to the other six provinces in Central Luzon.

In this connection, NNC would like to request your good office to endorse this endeavor and seek support from the School Division Superintendents in the remaining six (6) Provinces of Central Luzon. We requested the assistance of the Provincial Nutrition Action Officers of the provinces to coordinated with the Provincial School Division of the DepEd with regards to administrative concerns.
