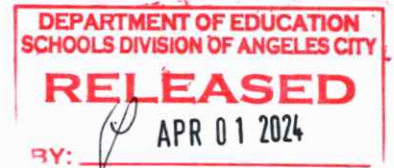

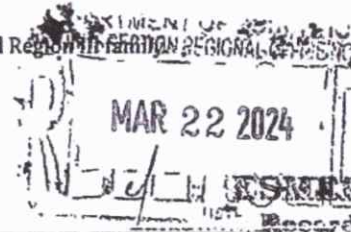
1. **issuing an Endorsement** of the 21st ARHEI-III Assembly,
