

COUNCIL MEMORANDUMNo 04s.2024



To: School Principals and Administrators of Public and Private Secondary Schools

1. The BSP Angeles City Council will conduct "1<sup>st</sup> Scout Anti-Bullying Workshop with the theme: "MISAUP-SAUP: Scouts Help Prevent Bullying" on June 29, 2024, from 8:00 am to 12:00 noon at Sto Rosario E/S covered court.

- 2. The Objectives of the activity are as follows:
  - a. To help senior Scout Leaders be aware of different types of bullying;
  - b. To help Senior Scout leaders be informed of different strategies to help prevent bullying;
  - c. To make Senior Scout / Adult leaders advocates of anti-bullying in their unit and schools;
  - d. To help in the Scouts SDG program 3,4,10 and 16
    - 1. The learner has the capacity to perceive when others need help and to seek help for themselves or others;
    - 2. The learner is able to promote the empowerment of young people;
    - 3. The learner is able to identify and analyze different types of causes and reason for inequalities; and
    - 4. The learner is able to collaborate with the groups that are currently experiencing injustice and/or conflict.
- 3. Participants are as follows;
  - a. Registered Adult Leaders
  - b. Registered Senior Scouts, Eagle Scout and Rover Scout

4. Participation of the teachers and learners shall be purely voluntary and will not hamper the instructional time in compliance with the provision of DepEd Order No. 022, s. 2023 titled Implementing Guidelines on the School Calendar and Activities for the School Year 2023-2024, and DO No.9 s. 2005 titles Instituting Measures to Increase off –campus activities stated in the DO 66, 2017.
