This serves to acknowledge our receipt of your September 11, 2024 Memorandum, requesting for the transfer of the voting center of Barangay Claro M. Recto, Angeles City, Pampanga, from C.N. Dayrit Elementary School (CNDES)¹, M.L. Quezon St., Barangay Lourdes Sur East to Claro M. Recto Information and Communication Technology (ICT) High School (CMRICTHS), Doña Aurora St., Barangay Claro M. Recto, all of said city.

The reason cited for the request is that the present voting center, which presently houses Barangays Agapito Del Rosario, Claro M. Recto and Lourdes Sur East, comprising a total of fifty-eight (58) established precincts and ten thousand six hundred and seventy-seven (10,677) voters (both regular and SK) as of the October 30, 2023 Barangay and Sangguniang Kabataan Elections (2023 BSKE), is already congested. Hence, there is a need to transfer the voting center of Barangay Claro M. Recto to **CMRICTHS** in order to decongest the present voting center in the forthcoming May 12, 2025 National and Local Elections (2025 NLE).

You have attached the following documents to support your request:

- 1. A copy of your September 11, 2024 Certification, stating that you conducted ocular inspection of the present and proposed voting centers and found out that the former is already congested, in view of the increasing number of voters presently assigned thereat. On the other hand, the proposed voting center has sufficient space to comfortably accommodate the affected voters, is equipped with the necessary facilities for the conduct of electoral activities and more accessible, since it is only two hundred (200) meters away from the present voting center and the residences of the affected voters;
- 2. A copy of undated Letter of Mr. Randy A. Rosales, School Principal I, CMRICTHS, Department of Education (DepEd), Region III-Central Luzon,

Schools Division of Angeles City, allowing the use of their school as voting center of the affected barangay in the upcoming 2025 NLE; and

3. Photos taken during the conduct of ocular inspection of the present and proposed voting centers.

You are thus hereby directed to comply, with our September 9, 2020 Memorandum re: Posting requirements re: request for transfer of voting center/correction/change of name/address of voting center as stated in Section 19 of Resolution No. 108842 dated January 25, 2023.

This serves to acknowledge our receipt of your September 24, 2024 Memorandum, requesting for the transfer of the voting center of Barangay Ninoy Aquino, Angeles City, Pampanga, from Marisol Bliss Elementary School (MBES), May Flower St., Barangay Ninoy Aquino, to Jose P. Dizon Elementary School (JPDES), Magalang Road, Barangay Pandan, all of said city.

The reason cited for the request is that the present voting center, which presently houses Barangay Aquino, comprising of thirty-nine (39) established precincts and eight thousand eight hundred and forty-seven (8,847) voters (both regular and SK) as of the October 30, 2023 Barangay and Sangguniang Kabataan Elections (2023 BSKE), is already congested and cannot hold anymore the increasing number of voters assigned to it in the forthcoming May 12, 2025 National and Local Elections (2025 NLE).

You have attached the following documents to support your request:

- 1. Your September 24, 2024 Certification, stating that you conducted ocular inspection of the present and proposed voting centers, and found that the former is already congested, in view of the increasing number of voters presently assigned thereat. On the other hand, JPDES is a suitable voting center in lieu of MBES, since it is accessible, more convenient and capable of providing facilities, supplies and necessary equipment to operate as a voting center. Its estimated distance is only five hundred (500) meters away from the present voting center and the residences of the affected voters;
- 2. September 24, 2024 Letter of Ms. Nenita H. Jorquia, School Principal IV, JPDES, Department of Education (DepEd), Region III-Central Luzon, Schools Division of Angeles City, allowing the use of their school as voting center of the affected barangay in the upcoming 2025 NLE; and

3. Photos taken during the conduct of ocular inspection of the present and proposed voting centers.

Upon evaluation, we find your request, together with its supporting documents, complete.

You are thus hereby directed to comply, with our September 9, 2020 Memorandum re: Posting requirements re: request for transfer of voting center/correction/change of name/address of voting center as stated in Section 19 of Resolution No. 108841 dated January 25, 2023.
