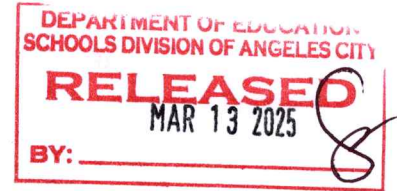

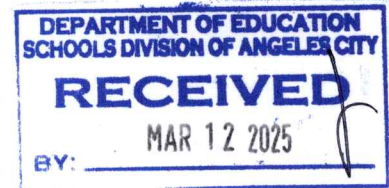



SUBJECT : 2025 REGIONAL SCOUT YOUTH FORUM (RSYF)

1. The Boy Scouts of the Philippines—Regional Coordination Office—Central Luzon is pleased to announce the **2025 REGIONAL SCOUT YOUTH FORUM**, which will be held from March 28 to 30, 2025, at Prenza National High School in Marilao, Bulacan. The Bulacan Council will host the forum.

2. The Scout Youth Forum, part of the Youth Development Program of the Boy Scouts of the Philippines, is organized to address the need and call for youth participation in the Scout Movement's decision-making process. It serves as a venue for information, training, and practical experience, allowing participants to discuss and gain a deeper understanding of various issues. Additionally, it acts as a source of inspiration by connecting individuals with new people, fresh ideas, innovative thoughts, diverse experiences, and different working methods.

3. **General Qualifications.** For an individual to qualify to participate in a Scout Youth Forum, the following standards must be met:

For Senior Scouts

- a. Must be currently registered Senior Scout
- b. Must have been elected in prior levels of the Scout Youth Forum
- c. Must have an official Scout Uniform (Type "A")

For Accompanying Adult/s

- a. Must be currently registered Adult Leader
- b. Must have been officially designated by the Council Office
- c. Must have an official Scout Uniform (Type "A")
- d. Must be fully conversant about the Scout Youth Forum

4. **Registration Fee.**

Attendance and participation in the local council's three (3) official delegates, two (2) observers, and one (1) accompanying adult is **FREE OF CHARGE** but not transferable.

For other participants (additional observers and accompanying persons), each shall pay a forum fee of **Eight Hundred Fifty (Php850.00)** to cover food (PM Snacks from 28 March 2025 to Lunch on 30 March 2025), souvenirs, and forum materials.

Registration Fee for the Regional Scout Youth Forum must be remitted directly to the host council, with the following details:

The registration Fee is nonrefundable but transferable. It must be paid to the host council **on or before 15 March 2025.**

The Reply Slip of Participants (see attached) and original copies of the deposit slip (not photocopy) must be submitted to the host council or the venue and sent a scanned copy to clr@scouts.gov.ph regional email.

5. **Participation.** Relative to the Revised Guidelines on the Conduct of the Scout Youth Forum promulgated through National Office Memorandum No. 15, Series of 2014. **Each Council shall send three (3) Official Forum Delegates and can also send a maximum of two (2) Observers to the Scout Youth Forum but shall have no voting rights.** The deadline for submission of Reply Slip is on or before 15 March 2025.

Things to bring:

1. Type A Uniform
 2. Beddings
 3. Toiletries
6. **Elections.** The Scout Youth **Forum requires** only two (2) elections: [1] the election of the forum officials, otherwise known as the Steering Committee, and [2] the election of the Scout Representatives to represent the Boy Scout membership in their respective policy-making bodies.
7. **Scout Representatives.** Scout Representatives shall be elected from among the official voting delegates to the Scout Youth Forums only.
