Warm Greetings from the Civil Service Commission Regional Office III!

In line with the celebration of the 125th Philippine Civil Service Anniversary (PCSA) this September, the Civil Service Commission is pleased to announce the conduct of the 2025 PCSA Fun Run, themed **"AGELESS MOVES: WELLNESS AND FUN RUN."** This activity will be part of the month-long PCSA celebration and shall be held on 07 September 2025 (Sunday), at 4:00 a.m., at Megaworld Capital Town, Sto. Niño, City of San Fernando, Pampanga.

The event aims to:

- Promote awareness and raise funds for the Pamanang Lingkod Bayani (PLBi) program of the Civil Service Commission;
- Encourage physical and mental well-being among public servants; and
- Foster inclusivity by welcoming the participation of senior citizens, persons with disabilities (PWDs), pregnant employees, and personnel of all fitness levels, regardless of age, gender, religion, disability, or any other distinguishing characteristics.

The proceeds will go directly to the **Pamanang Lingkod Bayani (PLBi) Fund**, which supports the families of public servants who have died in the line of duty⁹⁵. Eligible beneficiaries will receive a one-time financial assistance amounting to One Hundred Thousand Pesos (₱100,000.00). Furthermore, the children of PLBi awardees may be recommended for scholarship grants in state universities and colleges.

In this regard, we respectfully invite your agency to participate by encouraging your officials and employees to join this meaningful initiative. A non-refundable registration fee of Two Hundred Fifty Pesos (₱250.00)⁹⁶ for each participant shall be collected.

Registration for your agency should be coordinated by your Agency Human Resource Management Officer (HRMO) using the attached registration form. The registration fee may be settled at the nearest CSC Field Office or CSC Regional Office III, located at Diosdado Macapagal Government Center, Brgy. Maimpis, City of San Fernando, Pampanga.

- Accomplished Registration Form;
- Signed Release and Waiver of Liability Agreement; and
- Copy of the Official Receipt as proof of payment.
