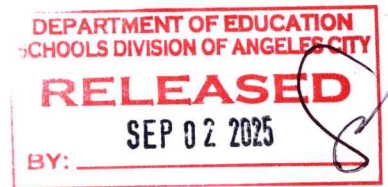

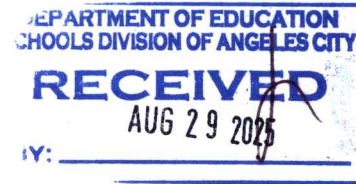

Attached herewith is the communication letter of the CWC together with **the** list of required documents for the PACFMC National Validation Visit for your reference and appropriate action.

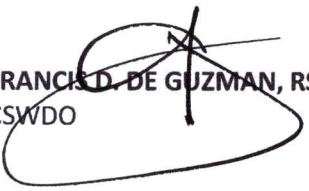

Dear **MAYOR LAZATIN:**

Greetings from the Council for the Welfare of Children (CWC)!

We are pleased to inform you that the **City of Angeles, Pampanga** has been shortlisted as a National Finalist under the **Highly Urbanized City (HUC)** for the 2025 Presidential Award for Child-Friendly Municipalities and Cities.

As part of the next phase, a validation team composed of five (5) members of the PACFMC National Award Committee (NAC), will conduct a national validation visit to your LGU.

In line with this, we are respectfully requesting the assistance of your good office on the following:

1. Billeting of validation team members in a safe and affordable lodging house within the area to be visited, the expenses of which will be borne by CWC;
2. Provision of vehicles to be used for the whole duration of the validation; and
3. Coordination with the abovementioned LGUs on the details of the visit.

Please see Annex A for further details.

Aside from document review, the validation team will visit five (5) barangays, one (1) of which will be your designated model barangay. The remaining barangays will be selected at random by the team in the presence of the Local Chief Executive. Hence, we recommend advising all barangays to prepare the necessary documents and reports, which will serve as means of verification for the assessment.

In addition, we are requesting a one (1) page write-up about the **City of Angeles, Pampanga** highlighting its initiative in promoting and protecting the rights of the children on or before **24 October 2025**.
