APPLICATION FOR PERMISSION TO STUDY

INSTRUCTIONS

- 1. Application for permission to study in five (5) copies must reach the office not later than two (2) months before the start of the actual classes. The TEACHER MUST FILE THE REQUEST BEFORE ENROLLING FOR THE FIRST TIME IN ANY SCHOOL, COLLEGE OR UNIVERSITIES.
- 2. The teacher-applicant must be doing satisfactory work with an efficiency rating above average or higher.
- 3. The permission is given until the applicant completes the curriculum towards a degree. He/she does not need to file a request for permission every semester.
- 4. A certification from the head of the school or college where the teacher is enrolled and the subject to be pursued should be attached.
- 5. Teacher who are about to finish the course, or who have started a course, as well as the subjects already completed and those still to be taken to be certified by the registrar of the private schools concerned.
- After each semester, every teacher granted permission to study should submit to the Schools Division Superintendent's office through channel, a certified true copy of the report on the ratings obtained in the course which he/she took during the semester, including the number of units earned. In addition, as he/she finished a specific curriculum towards a degree, he/she should submit a complete set of his/her transcript of records/ or grades, and special order to the Schools Division Superintendent through his/her immediate superior, for validation and verification.
- 7. The maximum of nine (9) units per semester and on summer should be strictly observed. Teachers who are candidate for graduation may be allowed to carry from one (1) to three (3) units more than nine (9) units authorized, provided these units are needed by the teacher/s to enable them to graduate. No exception will be allowed, if the teacher/s do not fall under the above state or condition. Violation of this regulation on study, shall be sufficient cause for revocation of the permission to study or for administrative action.
- 8. The college, schools or universities in which the teacher contemplated enrolling be accessible to his official stations so that he will not be unduly compelled to hurry from there, in order to arrive his/her class time. The teacher should attend to his/her outside study not earlier than thirty (30) minutes after the afternoon session in the public school.
- 9. The immediate superior shall be held strictly responsible for any undue delay in forwarding the application to the Schools Division Superintendent, if the application has been filed on time.
