

and Secondary Schools**

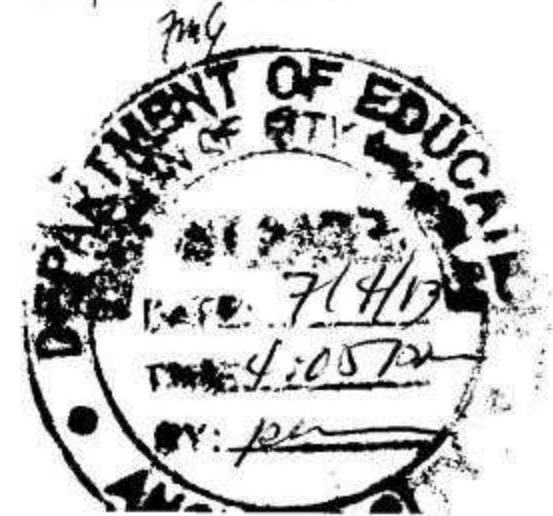

ANNEX B

Screening of Athletes' Records, Age Requirement & Residency Rule

1. All schools/districts shall conduct screening of athletes and examination of records during the preliminary meets. Birth Certificates (BC) must be original and compulsory.
2. Age Requirement:
 - Elementary Level - Born on or after January 1, 2001
 - Secondary Level - Born on or after January 1, 1996
3. A certified true copy extracted from the original or a photocopy/computer print-out of Form 137 (second grading period already posted) with fresh signature of teacher-adviser, school head/principal/registrar.
4. Medical and Dental certificates with printed name ^{and signature} of physician and dentist and license numbers.
5. Parent Permit with printed name of parent and signature. If guardian, Affidavit of Guardianship duly notarized.
6. Athletes' Personal data Form (Form 1) Athletes gallery (entry Form) to be accomplished with two (2) passport size or 1 ½ " X 1 ½" identical pictures with name tag and grade/year level (Surname, First Name, MI)
7. The one-year residency rule had ^{was} been modified to allow student-athletes from one division/region to another to compete, provided that the transferee athlete has been enrolled at the beginning of the school year (June). Student-athletes who transferred after the enrolment period of the current school year are disqualified.
8. Filipino students who have acquired foreign citizenship are not allowed to play in the DepED School Sports Program, and this, also applies to foreign students.
