Attention is invited to DepEd Order No. 66, s. 2007 for the criteria for ranking and the required documents to be submitted and to Item 15, CSC Memo No. 3, s. 2001 on the Three Salary Grade Limitation on Promotion, which states that, "An employee may be promoted or transferred to a position which is not more than three (3) salary, pay, or job higher than the employee's present position."
- 4. The appraisal of documents for ranking using DepEd Order No. 66, s. 2007 is reckoned from the date of the first day of the latest appointment. For example, you were promoted as Head Teacher on July 1, 2008. Now that you would like to apply as an Education Program Supervisor, only your accomplishments from July 1, 2008 onwards shall be given credit. All accomplishments prior to July 1, 2008 will not be given credit.
- All interested personnel, whether affected or not, may apply for the open positions, provided they meet the requirements of the applied position (per DepEd Order No. 53, s. 2013).
- All interested applicants who meet the basic qualification standards must submit a letter
 of intent indicating the specific position that an applicant is applying for and all other
 pertinent documents directly to Mr. Enrique Pangilinan, Administrative Officer V on or
 before January 16, 2015.
