CHANGES IN AND ADDITIONAL INFORMATION TO DEPED MEMORANDUM NO. 86, S. 2016
(2016 Philippine Youth Games-Batang Pinoy)

1. The **2016 Philippine Youth Games-Batang Pinoy** was announced through DepEd Memorandum No. 86, s. 2016. However, the following changes have been made:

a. Paragraph No. 1 is corrected to read as follows:

*The Philippine Sports Commission (PSC), in partnership with the Department of Education (DepEd), will hold its **2016 Batang Pinoy National Championships** from November 27 to December 2, 2016 instead of October 24-29, 2016. This will be hosted by the Davao del Norte and Tagum City.*

b. Paragraph No. 3 is also corrected to read as follows:

*The DepEd, through its regional and school's division offices, shall extend its support to the successful conduct of the **2016 Batang Pinoy National Championships**.*

2. Moreover, the following additional guidelines are hereby issued:

a. For this event, the Commission shall grant a sponsorship subsidy amounting to Three Thousand Pesos (P 3,000.00) per athlete, on a first-come, first-served basis. The sponsorship subsidy shall be released to the athletes during the Games. A maximum of 75 athletes per local government unit (LGU) shall be subsidized. However, an LGU shall still be entitled to submit more than 75 athletes. Athletes with no LGU endorsement shall not be entitled to sponsorship subsidy. Only provincial, city and municipality representation shall be accepted. Barangay level endorsement shall not be accepted.
