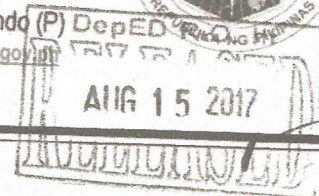

**REPORT ON THE STATUS AND PLANS ON THE IMPLEMENTATION
OF THE NATIONAL GREENING PROGRAM**

1. Relative to DepEd Memorandum No. 124, s. 2017, the Department of Education will conduct the National Educators Academy of the Philippines (NEAP) Greening Program on August 31 – September 01, 2017.
2. The activity is in support of Executive Order (EO) No. 26, s. 2011 declaring the Implementation of the National Greening Program (NGP) as a government priority program to reduce poverty, promote food security, environmental stability and biodiversity conservation, and enhance climate change mitigation and adaptation. Further, EO No. 193, s. 2015 has expanded the coverage of the NGP from 2016 to 2028. Government agencies are enjoined to provide support to the Program by mobilizing government employees and students to plant at least ten seedlings annually.
3. In view of this activity, the concerned Schools Division Offices (SDOs) are requested to submit a report on the status and plans on their SDOs' implementation of the National Greening Program. Likewise, each SDO is requested to submit a three-minute video presentation on the activities relevant to the program.
