The Japanese Government, through the Japan International Cooperation Center (JICE) and the Japanese Embassy in Manila in partnership with the Department of Education is now opening the application for the Japan East-Asia Network of Exchange for Students and Youths (JENESYS) 2017.

JENESYS 2017 is a people-to-people exchange program between Japan and the Asia-Pacific region launched by the Japanese government.

The programs aims to promote mutual trust and understanding among the peoples of Japan and the Asia-Pacific region and to build a basis for future friendship and cooperation. It also encourages an understanding and dissemination of Japan's economics, society, history, diverse culture, politics, and diplomatic relations.

For this batch, the JENESYS Program focuses on the theme: **Anti-Drug Education Program** in support of the national agenda on drug prevention and rehabilitation. The Department of Education (DepEd) shall be sending twenty-two (22) DepEd personnel for the program. The program will be on February 27-March 6, 2018 in Tokyo, Japan.

The program is only open to public high school teachers and non-teaching **DepEd personnel in the region, division, and schools.** The program is <u>not</u> open to students.

A. Qualification for Participants

- √ A bona fide Filipino citizen, under the age of 35
- ✓ Philippine passport holder (valid until August 27, 2018 or later)
- ✓ Mentally and physically fit to travel
- ✓ Can effectively communicate in English. Knowledge in speaking in Nihongo is an advantage.
- ✓ Must have strong interest in the theme of program, Anti-Drug Education.

B. Application Requirements

- ✓ Accomplished JENESYS 2017 Registration Form. Fill out the form with necessary information and answer in BLOCK LETTERS.
- ✓ Latest Curriculum Vitae
- ✓ **VISA Application Form.** Write complete name in BLOCK LETTERS and then sign using ballpoint pen; other areas on the form must be left blank.
- ✓ 1 Passport-sized photo. Staple the passport-sized photo taken within the last three (3) months on the allocated space on the JENESYS 2017 Entry Form.
- \checkmark 45mm x 45 mm photo. Staple the 45mm x 45mm photo taken within the last three (3) months on the allocated space on the VISA application form.
- ✓ Original Passport (valid until August 27, 2018 or later)
- ✓ Original and updated (2017) PSA Birth Certificate. Photocopy and/or Expired NSO Birth Certificate will not be accepted.
- √ Scanned copy of Information Page and Emergency Contact Page of Passport
- ✓ **Original NSO-certified Marriage Certificate.** Photocopy of Marriage Certificate will not be accepted (For married participants only.)

Note: Submission of plagiarized documents would mean automatic disqualification to the program

The following are automatically disqualified:

- Applicants who have already studied/stayed in Japan for over three months period
- Applicants who have already participated in JENESYS/KIZUNA, SSEAYP, JICA, Japanese Government (Monbukagakusho: MEXT) Scholarship Program, Invitation Program of Japan Foundation (JF), Japan National Tourism Organization (JNTO), or HIDA.

C. Terms and Conditions of the Program

The Japan International Cooperation Center (JICE) shall cover the ff. program-related expenses:

- Roundtrip economy class ticket from/to the international airport in home country to/from Japan;
- · Visa application fee
- Overseas travel insurance

- · Accommodation, transportation, and meals within the program in Japan
- · Admission fees for scheduled activities in Japan

For the Pre-Departure Orientation and Formation Program, travel expenses within the Philippines from their residence (province) to Manila (NAIA) and back shall be charged against their local funds, MOOE. Board and lodging, and meals for the qualified applicants shall be charged against 2017 CO-GAS funds, all subject to the usual accounting and auditing rules and regulations.

Please note that no cash allowance is provided to the participants. Participants shall pay their personal expenses, including passport fee, and purchasing souvenirs or personal goods before or during the program.

D. Application Procedures

Step 1 All interested applicants shall submit to Central Office (CO) all the original documents EXCEPT for their original Philippine passport. The original passport will only be sent to the Central Office once they qualify already to be part of the delegation.

Step 2 The JENESYS National Screening Committee (JENESYS NSC) will conduct the initial evaluation of documents and will only notify shortlisted applicants for interview.

<u>Step 3</u> Shortlisted applicants shall be invited to the CO for the national interview.

Step 4 The JENESYS NSC shall notify the applicants via e-mail/SMS regarding the final results.
