PARTICIPATION OF ACAAA DELEGATION TO THE 2019 CENTRAL LUZON REGIONAL ATHLETIC ASSOCIATION (CLRAA) MEET

- 1. Pursuant to R.M. No. 230, s. 2018, the DepEd Angeles City announces the participation of ACAAA (Angeles City Amateur Athletic Association) Delegation to the 2019 CLRAA Meet which shall be held at Iba Sports Complex, Iba, Zambales on **February 3-8, 2019**.
- 2. Therefore, to facilitate the Regional Screening and Accreditation of Athletes, Coaches, Assistant Coaches and Chaperons of the Division of Angeles City for the 2019 CLRAA Meet which is scheduled on **January 18, 2019 at 2:00 P.M.**, **Angeles Elementary School** as per RM No. 231, s. 2018, a **Division Pre-Screening** of documents of coaches and athletes shall be conducted on **January 11-12, 2019**, 8:00 A.M to 5:00 P.M, Gabaldon Building.
- 3. Likewise, an **Ocular Inspection** shall be conducted on **January 11, 2019** to check on the facilities, equipment and general state of the billeting schools for the safety, protection and welfare of the entire delegation.
- 4. In the same manner, a **Solidarity Meeting** shall be conducted on **January 29, 2019 at 1:00 P.M.**, **Gabaldon Building** to attain unities of interests, objectives, standards, and sympathies during the said meet.
- 5. Moreover, an **Intensive Training** for effective strength and conditioning of athletes and coaches who will participate in the **regular sports events** to be played in the 2019 CLRAA shall be conducted from **January 18, 2019** to **February 1, 2019**.

- 6. The ACAAA delegation is composed of Delegation Officials, Technical Working Committee, Athletes, Coaches, Chaperons, and Officiating Officials from both public and private schools.
- 7. Advanced Party which is composed of the Athletic Manager, Supply/Billeting Officers, and Engineering /Maintenance Officers shall leave on **February 1, 2019** to prepare the billeting schools prior to the arrival of the delegation.
- 8. The delegation shall depart on **February 2**, **2019 at 12:00 N.N**. The assembly area for the departure shall be in the Division Office.
- 9. Whereas, the delegation shall come back on **February 3, 2018**. The pick-up point shall also be in the Division Office.
- 10. All members of the delegation will stay in the billeting schools: **Batonlapoc Elementary School and Botolan South Central School** to realize the objectives of sports particularly the spirit of fellowship. However, participants from **private schools** with valid reasons for not staying must submit a letter to the Division Office with notarized **Authority and Waiver** signed by their sports officers and school officials on or before **January 28, 2019**.
- 11. Additionally, the ACAAA delegation must strictly adhere to the provisions of **DepEd Order No. 48**, **s. 2016** entitled "Policy and Guidelines on Comprehensive Tobacco Control", **DepEd Order No. 40**, **s. 2012** entitled "DepEd Child Protection Policy", **RA 10173** entitled "the Data Privacy Act of 2012", **DepEd Order No. 55**, **s. 2013** entitled "IRR of RA No. 10627, Anti Bullying Act", and the implementation of the **4S Strategy of the DOH** against dengue.
- 12. Furthermore, all athletes, coaches, chaperons, officiating officials **are prohibited** from going to places other than the Iba Sports Complex and designated playing venues.
- 13. All schools are expected to extend their full support to their students and teachers who have been selected as athletes, coaches, chaperons, officiating officials and members of technical working committee during the intensive training and 2019 CLRAA and hereby enjoined to comply with the mandates of **Education Act of 1982**, **Rule III**, **Section 3**, (e) that teachers shall refrain from making deductions in the scholastic rating of pupils/students, for any act that is clearly not a manifestation of poor scholarship and **DepEd Order No. 66**, **s. 2017**, Paragraph 2, (b) uphold child protection policy principles and that no learner shall be disadvantaged in any form.
- 14. Also, teachers who have been selected as coaches, chaperons, officiating officials and members of the technical working committee during the intensive training and 2019 CLRAA shall make necessary arrangements to compensate the lost number of days in accordance with **the DepEd Order No. 9, s. 2005**, entitled "Instituting Measures to Increase Engaged Time on Task and Ensuring Compliance Therewith" and strict compliance with 180 days Teaching and Learning Guidelines.

- 15. All expenses relative to all the activities for the 2019 CLRAA will be funded out of the Special Purpose Funds, chargeable against the LSB-**Special Education Fund** (SEF).
- 16. This Memorandum serves as the Authority to Travel of all concerned.

17. Immediate and wide dissemination of and strict compliance with this Memorandum is desired.
