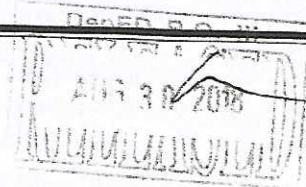

**2018 SEARCH FOR THE SCHOOL BEST IMPLEMENTER OF
GULAYAN SA PAARALAN PROGRAM (GPP)**

To : Schools Division Superintendents
Public Elementary and Secondary School Heads
Others Concern

1. The Department of Education Regional Office III through the Education Support Services Division (ESSD) shall conduct the 2018 Search for the School Best Implementer of Gulayan sa Paaralan Program (GPP).
2. The objectives of this search are:
 - a. To validate the implementation of GPP relative to its objectives.
 - b. To document best practices which can be shared to other implementers.
 - c. To recognize the efforts of the best implementing schools.
3. The Schools Division may conduct its own search on the division level to come up with the best entry for the regional search.
4. The Regional Search Committee is composed of:

Chairman: Crisel Pantalunan – GPP Regional Coordinator
Members: Dr. Leoncio Del Corro – Dentist
Illuminado Garcia Jr. – Draftsman II
5. The following guidelines shall be observed:
 - a. There will only be one (1) entry from each SDO which can either be an Elementary or Secondary School.
 - b. Schools with no contribution to the School-Based Feeding Program are excluded in the search.
 - c. The entry school can either be a recipient or non-recipient of the GPP financial assistance.
 - d. The search committee will ask for Means of Verification (MOVs) on certain criteria when deemed necessary. The absence of MOVs may result to decrease in points or disqualification on the search.
 - e. Submission of entry to the Regional Office (ESSD) shall not be later than October 26, 2018. Entry beyond this date shall not be accepted. Validation of documents will be on the scheduled on-site validation.

g. Winners shall receive a plaque of recognition and the school garden/EPP teacher shall receive certificate of recognition and others shall be given certificate of participation. Cash prizes shall also be given to the winners (1st Place – Php 50,000.00, 2nd Place – Php 30,000.00 and 3rd Place - 20,000.00).

7. On-site validation will commence on November 5, 2018.
