CONDUCT OF CAMPUS IMPACT AMONG SELECTED SCHOOLS

To: All Heads of Following Selected Public Schools:

- Francisco G. Nepomuceno Memorial HS
- Angeles City National HS
- Angeles City National Trade School
- Rafael L. Lazatin Memorial HS
- Bonifacio V. Romero HS
- Northville 15 IS
- 1. The "By His Grace Family Church Inc." is offering a character, values and career formation program entitled CAMPUS IMPACT among schools for free. The project proponent, Pastor Rick Zapanta, had presented the program to the Division Office. Specifically, it aims to engage students to practical, psychological and spiritual teachings that will challenge them to evaluate their current situation in order for them to assess and plan initial actions towards fulfilling their dreams/vision. The program is intended for grade 10 students of the abovementioned selected schools.
- 2. Based on assessment of their school's situation, capability and students' needs, the school heads of the selected schools may allow the conduct of the said CAMPUS IMPACT in their schools observing the guidelines stipulated in **DECS Order 39**, s. 1987 and **DepEd Order 49**, s. 2009 Reiterating the Revised Rules and Regulations on the Teaching of Religion/Values Education in Public Elementary and Secondary Schools.
- 3. To ensure compliance to the abovementioned department orders, concerned school heads must ensure the following provisions in the conduct of the said program:
 - a. It shall be given to grade 10 students on a separate time/schedule and should only be held within the school premises. To ensure time on task and no class disruption policies of the department, it shall NOT be conducted during the time of any particular subject specifically EsP/Values Education; nor during recess/lunch time of students.
 - b. It is purely on voluntary basis with parental consent and supervision of the class advisers and teachers to ensure safety and protection of the students.
 - c. It must not border on religious indoctrination and membership recruitment for a particular religion or association.
 - d. There must be no collection of any fee or contribution in the conduct of the program.

- e. A Partnership Memorandum of Agreement (MOA) between the school and *By His Grace Family Church Inc*. stipulating the above provisions and other agreed terms and conditions must be executed prior to the conduct of the said program.
- 4. Monitoring and evaluation (M&E) must be conducted by the school to evaluate compliance to the above provisions and assess the impact of the said program to the values/character formation of the learners. The report and results of the monitoring & evaluation must be submitted to the Education Program Supervisor in charge of EsP/Character/Values Education.

5. Immediate dissemination of this advisory to concerned schools is desired.
