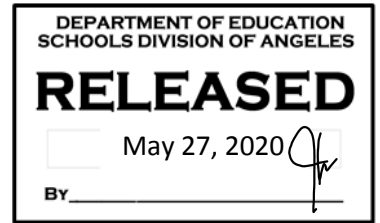



**UTILIZATION OF DEPED RESOURCES/MATERIALS FOR TRAININGS
CONDUCTED BY NON-DEPED LEARNING SERVICE PROVIDERS**

1. Pursuant to the OUA MEMO 00-0520-0015 from Undersecretary **ALAIN DEL B. PASCUA**, DepEd Central Office, relative to the received reports on the conduct of Webinars by Non-DepEd Learning Service Providers involving some DepEd employees as board members, collecting registration fees and using training materials from ICT Service without permission, this Office strongly **"discourages and prohibits"** the use of DepEd resources/materials for trainings conducted by private individuals and organizations **"without permission and authority"** from the Department.
2. In accordance with DepEd Order No. 001, s. 2020 articulating the *Guidelines for NEAP Recognition of Professional Development Programs and Courses for Teachers and School Leaders*, item VII.A, Non-DepEd Learning/Training Service Providers shall comply first with the requirements of the Authorization and Evaluation Process prior to submission of professional development programs and/or courses, and Philippine Regulation Commission (PRC) Accreditation for the equivalent units required in the renewal of PRC Teacher's License.
3. In view of the foregoing premises, Schools Division Offices (SDOs) are enjoined to evaluate and validate the "DepEd Authorization" and "PRC Accreditation" of these Non-DepEd Learning Service Providers to ensure the observance and implementation of this policy guideline relative to Learning and Development Programs for teachers and school leaders.
4. Wide dissemination of this Memorandum to all concerned is desired.
