CONDUCT OF THE EVALUATION AND FEEDBACK ONLINE SURVEY ON THE SCHOOL-BASED FEEDING PROGRAM (SBFP)

To: School Heads of Public Elementary Schools and School SBFP Coordinators

1. The School Health Division (SHD) shall conduct an Evaluation and Feedback Survey (EFS) on the School-Based Feeding Program (SBFP) which aims to gather feedback from the parents and/ or guardians of the beneficiaries and the field implementers on the implementation of SBFP for SY 2020-2021 and their perceived benefits to the program recipients
2. The objectives of the School-Based Feeding Program Evaluation and Feedback Survey are to:
 - a. Obtain the parents'/ guardians' perception on the effects of the program to the beneficiaries who received Nutritious Food Products (NFP) and Fresh/Sterilized Milk;
 - b. Gather the school feeding coordinators' feedback on the management and the implementation of the program;
 - c. Gather the parents'/ guardians' satisfaction/ acceptance of the program
 - d. Identify the issues and concerns that may be associated with the implementation of the program; and
 - e. Identify areas for improvement and recommend action plans.
3. There will be two sets of questionnaires, one intended for the parents and/ or guardians, and another one for the school feeding coordinators in recipient schools. These surveys are thru Google Forms, and can be accessed through the following link
