- Please be informed of the conduct of the Final Validation of the Regional School Safety Assessment Tool (RSSAT) / Monitoring of the Division District Composite Teams to all Public Schools except Malabanias IS and Dr. Clemente M. Dayrit Sr. Memorial High School on March 8 from 8:00-5:00 and March 9, 8:00-12:00, 2022.
- 2. The objectives of the said Monitoring are:
 - a) to validate the School Assessment Tool relative to the implementation of the Progressive Expansion of Limited Face to Face Learning;
 - to determine the compliant schools for the implementation of Progressive Expansion of Limited Face to Face Learning;
 - to know the condition of the teaching-learning environment now that government workers are required to report to work under Alert System Level 1 and students are going back to schools in progressive number, and,
