



#### SUBMISSION OF W.A.T.C.H CLUB AND OTHER W.A.T.C.H REPORTS AND NATIONAL AWARDING FOR THE BEST SCHOOL IMPLEMENTERS

- Pursuant to Department of Education (DepEd) Memorandum No. 410 s, 2009. titled Guidelines on the Establishment of a W.A.T.C.H School (We Advocate Time Consciousness and Honesty), the External Partnerships Service (EPS) in collaboration with the Junior Chamber International (JCI) Senate Philippines informs the DepEd field units about the implementation of 2022 Project W.A.T.C.H.
- Project W.A.T.C.H aims to push forward the recognition of punctuality and honesty as two core values in promoting renewal and development. This year's theme is anchored on Working Towards a Culture of Integrity through Honesty and Time Consciousness.
- The following provisions shall be adopted in this year's Project W.A.T.C.H implementation.
  - a. All W.A.T.C.H implementers shall include the logos of Project W.A.T.C.H, DepEd and JCI Senate Philippines in all their activities and marketing collaterals including backdrops, poster and other relevant materials to Project W.A.T.C.H activities;
  - b. All W.A.T.C.H advocates are enjoined to adopt another school. The adoptive school shall guide the adopted school in creating/organizing a W.A.T.C.H Club and shall assist in the conduct of the adopted school's trainings and activities. The adoptive school and the adopted school shall execute a document indicating the adoption and shall be signed by the school heads of both schools. In addition, special award shall be given to the top three (3) adoptive schools and;
  - c. An award shall be given to the top three (3) New Implementers. A school, who had joined in the previous selection for the National Search for the

Outstanding W.A.T.C.H Schools but had not participated in any Search after 2016 may qualify for this award.

- 4. Relative to the Project W.A.T.C.H implementation, all W.A.T.C.H advocates and implementers are encouraged to have an Honesty Store or any Project with similar concept. In so doing, it aims to teach learners the importance of honesty by allowing them to buy and pay through an honesty system by dropping their payment into a money container. For such practice, it will instill honesty as a habit, which will eventually become a virtue that will shape the character of the learners to value honesty.



The Ebook Report to be submitted must show best practices amidst challenges faced during the COVID-19 pandemic. The report must be substantiated with supporting evidence such as certifications, pictures, programs, narrative reports of accomplishments and video documentation.

#### VIDEO DOCUMENTATION REQUIREMENTS

The following are the requirements on the creation and submission of the video documentation:

- Must show video of best practices amidst challenges faced during COVID-19 pandemic;
- 2. Must be a high-quality Audio-Visual Presentation in MP4 format;
- Must be uploaded to the official JCl website. In case of inability to upload due to limited accesss/connectivity, it must be saved in a flash drive (use of CDs/DVDs is discouraged); and
- 4. Must not run for more than five (5) minutes.
- Must contain shots within the prescribed timeframe: November 1, 2020 to October 25, 2021.
- 6. Must be submitted and labeled with the following information:
