

5. The Basketball games shall be played on the following designated playing venue:
- a. Cluster 1 – is composed of the teams of SDO's Nueva Ecija (host), San Jose City, Munoz City, Cabanatuan City and Gapan City. Playing venue is at the Schools Division Office of Nueva Ecija Gymnasium, Sta. Rosa, Nueva Ecija. Billeting of the players and technical official shall soon be announced by the SDO-NEU host.
 - b. Cluster 2 – is composed of the teams of Tarlac City (host), Tarlac Province, Mabalacat City and Angeles City. The game will be played at Dona Marina Gymnasium and the billeting of the players and officials is at the Sto. Cristo Integrated School, Tarlac City.
 - c. Cluster 3 is composed of the teams of the SDO's of Zambales Province (host), Bataan Province, Balanga City, Olongapo City and the Regional Office Team. The games will be played at the Gymnasium facility and the billeting place of the players and technical officials will be announced later. and
 - d. Cluster 4 is composed of the teams of the SDO's of Bulacan Province (host), Malolos City, City of San Jose Del Monte, Pampanga and San Fernando City. Basketball Tournament of DEPED-NEU REGION III CHAPTER

TEAM GUIDELINES

(Players, coaches, assistant coaches & other team officials)

1. Eligibility
 - 1.1 Based on the NEU Guidelines
2. Team composition
 - 2.1 A team shall be composed of not more 15 team members and a coach
3. Coach
 - 3.1 A team shall be headed by a responsible Coach.
 - 3.2 Only the Official coach and Assistant shall be allowed to stay within the team bench during official games. (If in case head coaches are not available, their team captain may assume his/her position)
- a. TIMING REGULATIONS
 1. The game shall consist of 4 periods. The periods shall be played in **10 minutes** in the **1st, 2nd and 3rd** quarter and **10 minutes** in the **(4th) fourth** quarter (5 minutes for every extra period.)
 2. The intervals between periods, is one (1) minute while the interval between halves is 3 minutes.
- b. PLAYERS PLAYING REGULATION
 1. The official FIBA rules shall apply.
 2. A team shall have Three (3) players at least aged forty (40) and above years of age. (or more)
 3. Two (2) player aged 40 and above shall play at least 5 minutes in the 1st to 3rd quarters.
NOTE: In the 2nd and 3rd Quarters the opposing team can choose who among the players aged 40 and above shall play for at least 5 minutes, in case their forty years old player is less than 4 persons.
 - 2nd and 3rd quarter opening 5 players (also includes 1st quarter)
 - Substitute player/s (also includes 1st quarter)
 4. In the (4th) fourth quarter any of the players can be fielded in or play.
 5. Absence of players who are forty (40) and above shall be penalized with a game disqualification (Forfeiture).
- c. In case of disqualification
 1. A thrown out player must leave the confines of the play

2. A player/coach who is disqualified as a result of a disqualifying foul/fighting or the like, subject will be automatically suspended. The number of games suspension shall be determined by the Tournament Supervisor/Tournament Manager.

- d. RULES OF CONDUCT
 1. FOULS
 - 1.1 TECHNICAL FOULS – Any player/coach who displays unsportsmanlike conduct or disrespectful act such as slashing of neck, showing of dirty fingers, pointing of accusing finger and trash talking/shouting bad words/foul language, contesting calls, arguing with the officials and others. A Warning maybe given or a technical foul shall be slapped (TWO (2) TECHNICAL FOUL MEANS SUSPENSION FOR THE NEXT GAME.)
 - 1.2. PERSONAL FOULS – a player causing contact with an opposing playmate, which gives an unfair advantage and such contact are neither intentional nor flagrant.
 - 1.3. FLAGRANT FOULS – a player causing excessive contact which may cause or have caused injury to an opponent, such as; a) excessive swinging of elbow; b) throwing a punch; c) tripping; d) intentional contacting or pushing the back of a player going for a basket shall be judge to be either an UNSPORTSMANLIKE/DISQUALIFYING FOUL.
 - e. PLAYERS' and COACHES' CONDUCT:
 1. Any PLAYER/ COACHES' who is slapped with a disqualifying foul and ejected because of **FLAGRANTLY UNSPORTSMANLIKE ACTION**, shall be penalized and with an additional 1 game suspension/total disqualification or banned from further participation, depending on the gravity of the offense. (as may be determined by the Tournament Supervisor/ Tournament Manager)
 2. Uttering/shouting of obscene/foul language/bad words or verbal abuse form players, coaches and asst. coach to opponents/officials or teammates shall not be tolerated. Such act shall be dealt with a **warning or a technical foul**.
 3. Team shall keep and leave their benches areas clean and orderly. Noncompliance shall be dealt with a warning or a technical foul.

 4. Coaches shall always confirm their next schedule of the game with the tournament manager before leaving the playing venue.
 5. The basketball venue is a **NO SMOKING ZONE**.
 6. STRICT COMPLIANCE TO THE IATF GUIDELINES SHALL BE STRICTLY IMPOSE.
 - f. GAMES DISRUPTION

Games which are cancelled/disrupted/stopped due to FORCE MAJEURE or for any valid reason, will be treated in the following manner:

1. RESUMPTION – if the disruption of the game took place during the game, the game shall be resumed with the remaining game time.
 2. DURATION OF WAITING – in case of a power failure/heavy rain or any incident that may affect the progress of the game, the length of the time to wait for the restoration of normalcy is 30 minutes or as may be allowed by.
- g. FORMAT OF COMPETITION
1. Bracketed double elimination format, top (1) one team in each bracket will advanced in the semifinals (Knockout game) wherein A1 vs D1, B1 vs C1, Winners of this matches will advance in a knockout championship game, while non-winners will settle for battle for 3rd place. (Refer to Official Game schedule)
 2. Law of Succession, five minutes (5 minutes) forfeiting time.
- h. In cases not specifically mentioned in this guidelines and ground rules FIBA rule shall apply. **The Tournament Supervisor/s and Tournament Managers** shall exert effort to maintain an orderly and friendly competition. The success of the competition depends on the cooperation of the Officials, coaches, asst. coaches, players and audience.

TOURNAMENT GUIDELINES
 (BADMINTON)

Venue of the Badminton games is at JCAS Alley, Mabolo, Malolos City, while the billeting of the players and technical officials is at the Malolos Marine Fisheries Laboratory School, Malolos City.

RULES:

- A. The competition shall be held in accordance with the current Laws and Regulations of the Badminton World Federation (BWF). However, in matters not covered by these rules and regulations, decisions shall rest with the Tournament Manager.
- B. The Technical Committee/Tournament Manager shall be responsible for the technical organization of the tournament. The decision of the committee in all matters regarding the competition shall be final.
- C. Only Team Captains or Managers are allowed to approach the Match Control/ Referee with regards to questions and inquiries during the match.
- D. Only the Official Coach or team captain listed on the registration are allowed to sit on the coaches' chair and approach the players during intervals.

II. TOURNAMENT FORMAT:

- A. The format of the competition shall be run on a single elimination or knock-out system for men's and women's doubles and mixed doubles.

III. EVENTS:

- A. Doubles Competition
 1. *Men's Doubles -(One (1) entry /Team)
 2. *Women's Doubles -(One (1) entry /Team)
 3. *Mixed Doubles -(One (1) entry /Team)

V. SEEDING/RANKING:

- A. Pairings in all events shall be done by electronic draw. There will be no seeding of players.

VI. DRAWING OF LOTS:

- A. Drawing of lots shall be done before the start of the Tournament (Electronic draw lots shall be implemented)
- B. The tournament manager shall be the one to make the draw to determine the opponent.
- C. Coach/representative's right to question the tournament proceedings or technical guidelines shall be waived if he/she fails to attend the Solidarity Meeting.

VII. ENTRY OF PLAYERS

- A. Each team shall be composed of 3 players, for both Men's and Womens Event.
- B. A player can only play in one event and no second entry shall be allowed.
- C. Entries must be submitted at least a week before the event to the organizing committee.
- D. Upon submission of the entries no substitution shall be allowed especially after the draw.

VIII. SCORING

- A. A straight 35 scoring system shall be applied with an exchange end and interval when score reaches 18.

IX. WALK-OVER:

- A. A fifteen (15) minute grace period upon call on the scheduled tie/match shall be given, otherwise the team/player shall be declared loser via walk-over.

X. ATTIRE:

- A. All players are required to be on a prescribed badminton uniform.
- B. Court officials shall wear collared T-shirts, Yellow/Red/Division shirt, black pants (slacks), black leather shoes and black socks when officiating.
- C. Coaches are required to wear proper attire during the competition. Wearing of sleeveless shirt, shorts and slippers when coaching is not allowed.

VII. PROTEST:

- A. Protest on eligibility will be settled at the level of the Organizing and Screening Committee.
- B. Protest on technicality will be settled at the level of the Tournament Referee/Tournament Manager.

- A. Court officials will not be allowed to officiate in a match if he/she is under the influence of liquor (alcoholic beverage).
- B. Smoking is strictly prohibited within the playing area—let us make badminton a smoke-free competition.

XIV. UNFORESEEN EVENT:

- A. The decisions of the Referee on any disputes during the competition shall be final.
- B. If the ongoing ties/matches will be impossible to continue; such ties/matches will be continued later from the point where it was disrupted.
