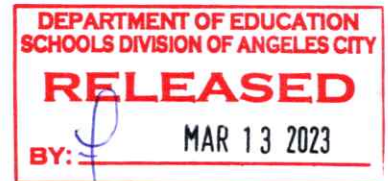

CONDUCT OF 2023 DIVISION MEET

1. In compliance with DepEd Memorandum No. 005, s. 2023, titled "Conduct of the Palarong Pambansa", the Schools Division of Angeles City, through the Angeles City Amateur Athletic Association, will conduct the 2023 Division Meet on **March 18-19, 2023**, in the different playing venues to be identified and prepared by the sports tournament managers on **March 17, 2023**.
2. The activity aims to identify and select the best teams and athletes who can confidently compete and advance to the 2023 Central Luzon Regional Athletic Association (CLRAA).
3. The participants are those who qualified during the district, public high school, and private school athletic meets.
4. The conduct of medical check-up, submission of documents, and screening of athletes and coaches will be on **March 14-15, 2023**.
5. Teachers designated as tournament managers who are involved in identifying and preparing the playing grounds for the aforementioned meet shall coordinate with their respective school heads to ensure compliance with DO 9, 2005, on Instituting Measures to Enhance Engaged Time-on-Task.
6. Likewise, all teaching and non-teaching personnel who will serve as tournament managers, technical officials, and coaches are entitled to service credit for attendance to this activity subject to the provisions of D.O. No. 53, s. 2003 known as "Updated Guidelines of Vacation Service Credits to Teachers" and Compensatory Time-Off and Overtime Credit in accordance with CSC and DBM Joint Circular No.2, s. 2004 on Non-Renumeration for Overtime Services Rendered.
7. All expenses related to the conduct of the said activity shall be charged to Sub-Allotment Release Order No. OSEC-3-23-0384, subject to the usual accounting and auditing rules .
