2023 REGIONAL SCHOOLS PRESS CONFERENCE (RSPC)

- 1. Pursuant to Republic Act (RA) 7079, otherwise known as the Campus Journalism Act of 1991, the Department of Education (DepEd) Region III announces the conduct of the 2023 Regional Schools Press Conference (RSPC) with the theme: "From Campus Journalism to Real-World Journalism: Shaping Minds from Schools to Societies" on May 20 and 27, 2023 in San Jose City, Nueva Ecija.
- 2. The conference aims to:
 - sustain advocacy on social consciousness and environmental awareness;
 - demonstrate an understanding of the importance of journalism by expressing it through different journalistic endeavors and approaches;
 - provide a venue for an enriching learning experience for students interested in Journalism as a career;
 - promote responsible journalism and fair and ethical use of social media;
 and
 - enhance journalistic competence through healthy and friendly competitions.
- 3. The participants in this training are the First, Second, and Third Place winners in the Individual Writing Contests and the First Place winners in the Team/Group Contests during the Division Schools Press Conference held last Dec 3 and 10, 2022.
- 4. There will be no registration fee. The Angeles City Government will provide two (2) buses as service vehicles and dinner for the participants in the billeting school on May 19 and 26, 2023. All other expenses relative to the conduct of the RSPC shall be charged against Division/MOOE/School MOOE/Local Funds/SEF or the School Campus Journalism Funds, subject to the usual accounting and auditing rules and regulations.
- 5. Participants are entitled to service credit for their attendance to this activity subject to the provisions of DepEd Order No. 53, s. 2003 known as "Updated Guidelines of Vacation Service Credits to Teachers and Compensatory Time-Off and Overtime Credit in accordance to CSC and DBM Joint Circular No. 2, s. 2004 on Non-Remuneration for Overtime Services Rendered."
