ESTABLISHMENT OF A FUNCTIONAL CHILD PROTECTION COMMITTEE (CPC) IN SCHOOLS

- 1. As stipulated in DepEd Order No. 40 s. 2012 titled "DepEd Child Protection Policy", all public and private elementary and secondary schools nationwide shall establish a functional Child Protection Committee (CPC) in schools which shall be composed of the following:
 - 1.1 Chairperson School Head / Administrator;
 - 1.2 Vice Chairperson Guidance Counselor/ Guidance Teacher Designate;
 - 1.3 Representative of the Teachers Designated by the Faculty Club;
 - 1.4 Representative of the Parents Designated by the Parent-Teacher Association;
 - 1.5 Representative of the Learners Designated by the Supreme Elementary Learner Government / Supreme Secondary Learner Government; and
 - 1.6 Representative from the Community Designated by the Punong Barangay preferably a member of the Barangay Council for the Protection of Children (BCPC)
- 2. With this, all Public and Private Elementary and Secondary schools are required to submit information and members of the Child Protection Committee (CPC) in schools through the School Child Protection Committee Form to be submitted at the SGOD Office before **July 17, 2023**.
- 3. In addition, the Chairman of the School Child Protection Committee (CPC) shall accomplish the 2023 CPC Profiling Form to avoid duplication of the entry from the same school through this link: https://tinyurl.com/2023CPCProfillingForm on or before **July 21, 2023**.

- Anent to DepEd Order No. 003 s, 2021 titled "Creation of the Child Protection
 Unit and the Child Rights in Education Desk in the Department of Education", thus,
 the Learner Rights Protection Office (LRPO) is tasked to lead in the planning,
 implementing, coordinating, monitoring and evaluation of programs, projects and
 activities (PPAs) relative to learner rights and protection in schools and across the all
 governance levels of the Department of Education (DepEd).
- In addition, the coordinating arms of the Learner Rights and Protection Office (LRPO) for the planning, implementation, monitoring and evaluation, reporting and coordination of learner rights and protection concerns are as follows.
 - 2.1 Education Support Services Division at the Regional Office;
 - 2.2 School Governance and Operations Division at the Division Office; and
 - 2.3. School Child Protection Committee at the school level.
- As stipulated in DepEd Order No. 40 s, 2012 titled "DepEd Child Protection Policy", all public and private secondary and elementary schools nationwide shall establish a functional school Child Protection Committee (CPC) which shall be composed of the following.
 - 3.1 Chairperson- School Head/Administrator;
 - 3.2 Vice Chairperson- Guidance counselor/Guidance Teacher Designate;
 - 3.3 Representative of the Teachers- Designated by the Faculty club;
 - 3.4 Representative of the Parents- Designated by the Parent-Teacher Association;
 - 3.5 Representative of the learners- Designated by the Supreme Elementary Learner Government/ Supreme Secondary Learner Government; and
 - 3.6 Representative from the Community- Designated by the Punong Barangay preferably a member of the Barangay Council for the Protection of Children (BCPC).

- Based on DepEd Order No. 40 s. 2012, the School Child Protection Committee (CPC) shall perform the following functions.
 - 4.1 Draft a school child protection policy with a code of conduct and a plan to ensure child protection and safety which shall be reviewed every three (3) years;
 - 4.2 Initiate information dissemination programs and organize activities for the protection of children from abuse, exploitation, violence, discrimination and bullying or peer abuse;
 - 4.3 Develop and implement a school-based referral and monitoring system.
 - 4.4 Establish a system for identifying students who may be suffering from significant harm based on any physical, emotional or behavioral signs;
 - 4.5 Identify, refer and if appropriate report to the appropriate offices, cases involving child abuse, exploitation, violence, discrimination and bullying;
 - 4.6 Give assistance to parents or guardians, whenever necessary in securing expert guidance counseling from the appropriate offices and institutions;
 - 4.7 Coordinate closely with the Women and Child Protection Desks of the Philippine National Police (PNP), the Local Social Welfare and Development Office (LSWDO), other government agencies, and non-governmental organizations (NGOs) as may be appropriate;
 - 4.8 Monitor the implementation of positive measures and effective procedures in providing the necessary support for the child and for those who care for the child; and
 - 4.9 Ensure that the child's rights to be heard are respected and upheld in all matters and procedures affecting their welfare.
- 5. Relative to this request, the Chairman of the school Child Protection Committee (CPC) shall accomplish the 2023 CPC Profiling Form to avoid duplication of entry from the same school through this link: https://tmyurl.com/2023CPCProfilingForm on or before July 21, 2023.
