LOCALIZED POLICY ON THE REQIUREMENTS AND SPECIFICATIONS IN THE IMPLEMENTATION OF SPORTS DEVELOPMENT PROGRAM

- 1. The 1987 Philippine Constitution, SECTION 19 paragraph (1) reiterates that the State shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry. Moreover, in paragraph (2) All educational institutions shall undertake regular sports activities throughout the country in cooperation with athletic clubs and other sectors.
- 2. Pursuant to Republic Act (RA) No. 10588, entitled "An Act Institutionalizing the Conduct of Palarong Pambansa and Appropriating Funds Thereof" as per joint Circular (JC) No. 1, s. 2017, Section 3.0, Legal Bases on the Use of the Special Education Fund (SEF), the Department of Education (DepEd) Schools Division of Angeles City together with the Angeles City Amateur Athletic Association (ACAAA) Board, hereby set the following Localized Policy on the Requirements and Specifications in the Implementation of Sports Development Programs:
 - 2.1 Sports Development Program covers the different sport programs and amateur sports activities such as: District, Public and Private High School Meets, City Division Amateur Athletic Association Meet, Participation to Regional Meet, Participation to Pre-National Qualifying Meet, and Participation to National Meet.
 - 2.2 Division Officials and schools whose students-athletes, coaches, assistant coaches, and chaperons are to participate in the amateur sports, technical officials, tournament managers, and supervising committee may receive the following incentives which will be charged against the Special Education Fund (SEF) under the Sports Development Program:
 - 2.2.1 Uniform;
 - 2.2.2 Sports equipment/goods;
 - 2.2.3 Cash Incentives;
 - 2.2.4 Supplemental allowance;
 - 2.2.5 Meals/meal allowance;
 - 2.2.6 Training allowance;
 - 2.2.7 Transportation allowance;
 - 2.2.8 Cash awards;
 - 2.2.9 Provision of drugs and medicines; and

2.2.10 Other incentives as ay be determined by the ACAAA Board.
