

#### ANNUAL PHYSICAL EXAMINATION OF TEACHING AND NON-TEACHING PERSONNEL

To: Assistant Schools Division Superintendent Division Chiefs

Heads of Public Elementary and Secondary Schools

- 1. Civil Service Commission Memorandum Circular No. 17, s. 1989 on "Physical and Mental Fitness for Continued Employment in the Public Service" provides that the Commission shall maintain a healthy government workforce that can adequately meet the demands of the service.
- 2. Moreover, pursuant to DECS Memorandum No. 184, S. 1993, and DECS Memorandum No. 500, S. 1997 and Regional Memorandum No. 58, S. 2003 regarding the Teacher's Health Welfare Enhancement Program, and as a manifestation of concern by this Division for the health status of its employees, all teaching and non-teaching personnel are required to undergo an annual physical examination to ensure that they are physically fit to perform their assigned roles and functions.
- 3. Listed below are the different diagnostic examinations required by the department, except for pregnant women in their first and second trimesters of pregnancy, who are advised to undergo SPUTUM MICROSCOPY. FASTING: Last meal is 10-12 hours before the procedure.
  - a) ECG
  - b) Fasting Blood Sugar (FBS)
  - c) Lipid Profile (Total Cholesterol, HDL, LDL and Triglycerides)
  - d) Blood Uric Acid (BUA)
  - e) CBC
  - f) Urinalysis
  - g) Creatinine
  - h) SGPT

- 4. Employees may avail themselves of the required laboratory examination for **P500.00** through on-site mobile services by St. Zacharia Clinical Laboratory at **Angeles Elementary School**, Personal Health Insurance, or the laboratory of their choice.
- 5. All results of the laboratory examination should be submitted to the School Health and Nutrition Unit of this division on or before **August 18, 2023**.
