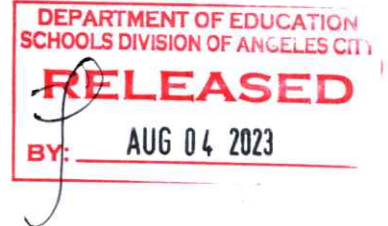

MOVEMENT/TRANSFER/REASSIGNMENT OF ELEMENTARY MASTER TEACHER POSITIONS

1. The Teacher Deployment Analysis for the previous school years consistently reveals imbalances in the deployment of master teachers. As such, it is imperative to effect transfers of master teachers from one station to another in order to ensure the equity of deployment.

2. As stipulated in **DepEd Order 22 s. 2013, “Revised Guidelines on the Transfer of Teachers from One Station to Another”**, section 3.c states that:

While efforts shall be exhausted to secure the consent of a teacher to be transferred, there are certain conditions which can validly be considered as “in exigency of the service” and transfers may be made even without the consent of the teacher. These include the following:



c. When the teacher is declared excess by the principal/ school head (SH) and his/ her expertise/ area of specialization is needed in another school/ district/ division.

3. In view of the foregoing circumstances, this Division hereby announces the movement/transfer/reassignment of Master Teachers I in the public elementary schools, **effective August 7, 2023.**

4. Attached is the list of Master Teachers I and their new school assignments.

5. It is enjoined that the concerned master teachers secure a School Clearance, as to money and property accountabilities which should be submitted to the Personnel Unit on or before **August 7, 2023.**

6. Immediate dissemination of and strict compliance with this Memorandum are directed.
