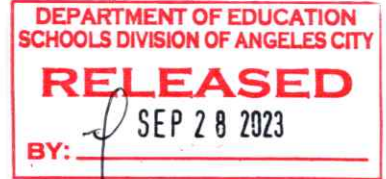

**DIVISION MEMORANDUM**

**DIVISION LOCALIZED POLICY ON THE ELECTION OF SCHOOL-LEVEL PARENT-TEACHER ASSOCIATION, AND DIVISION FEDERATED PARENT-TEACHER ASSOCIATION (DFPTA)**

To : Assistant Schools Division Superintendent  
OIC-Chief, CID and Chief, SGOD

Public Elementary and Secondary School Heads  
All Others Concerned

1. The Education Act of 1982 “An Act Providing for the Establishment and Maintenance of an Integrated System of Education” states the right of parents to organize by themselves and/or with teachers for the purpose of providing a forum for the discussion of matters relating to the total school program, and for ensuring the full cooperation of parents and teachers in the formulation and efficient implementation of such programs.

2. Pursuant to DepEd Order No. 13, s. 2022 “Omnibus Guidelines on the Regulations of Operations of Parent-Teachers Association (PTA),” streamlines the process for managing PTA affairs at the different levels which include election of PTA officers consisting of parent/guardian- and teacher-members under different modalities.

3. To respond to the different local issues and needs of schools, the Schools Division of Angeles City hereby sets the following Localized Policy on the Policy on the Election of School-Level Parent-Teacher Association:

- 3.1.1 Integrated schools, and schools with junior and senior high schools may elect PTA Officers in the elementary, junior, and senior high schools.
- 3.1.2 The elected PTA Persidents in the elementary, junior, and senior high schools in the municipality/city (in case of the Municipal/ City FF'IA) and the FPTA Chairpersons in the municipal/component city (in case of Provincial FPTA) shall elect from among themselves the Division Federated Parent-Teacher Association (DFPTA) Officers.
