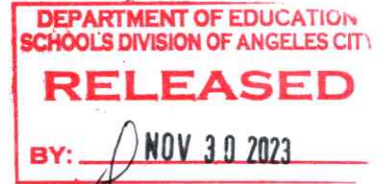

1. Please be informed that the **Regional Validation of School Governance Council (SGC) Functionality Assessment Tool** is on **December 5, 2023 (Tuesday), 8:00 a.m. to 5:00 p. m.** at the Gabaldon Building, Pulungbulu, Angeles City.
2. The objectives of this activity are the following:
 - 2.1. to validate the SGC Means of Verification (MOVs);
 - 2.2. to determine the schools' level of SGC functionality; and
 - 2.3. to provide TA to the schools in finalizing their SGC MOVs.
3. All MOVs are expected to be compiled per folder and per functionality indicator for easy validation.
4. The participants in this activity are the members of the Division SGC Composite Team, school heads, SGC designated co-chairman, SGC elected co-chairman, and SGC secretary of the select secondary schools.
5. Attached is the list of the secondary schools involved in the validation for information and guidance.
6. In connection to this, a coordination meeting among the Division SGC Composite Team members and the SGC officers of the select secondary schools is on **December 1, 2023 (Friday), 1:00 p.m. to 3:00 p.m.** via MS Teams.

Expenses relative to the conduct of this activity amounting to Php350.00 per participant shall be charged to School MOOE funds or other local funds for the participants from the school and Division MOOE funds for the participants from the SDO and RO, subject to the usual accounting, auditing and procurement procedures, and rules and regulations.
