Pursuant to DepEd Order No. 27, s. 2019, titled "Guidelines on the Yearly Collection of Data/Information Requirements and Validation Processes," the Department provides the basis for the annual data collection in the Basic Education Information System. It requires all public and private elementary, junior, and senior high schools, state universities and colleges (SUCs), and higher education institutions (HEIs) offering kindergarten to grade 12 to update their school profile and report other relevant data using the BEIS data gathering forms.
