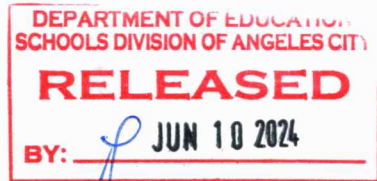

As specified in item 21 of the referenced Memorandum, incidental expenses incurred by official delegates shall be covered by the school's Maintenance and/or Other Operating Expenses, local funds, Special Education Fund, the School Campus Journalism Fund, and other sources as applicable. However, the travel expenses of student participants and coaches will be subsidized by the Central Office and charged against the Development and Promotion of Campus Journalism (DPCJ) funds. If the travel expenses of the participants exceed the allotted funds for their region/division, the remaining expenses shall be covered by any available source of funds. All expenses are subject to the usual accounting and auditing rules and regulations.
4. Teacher coaches are tasked with coordinating travel, accommodation, contest venues, and other logistical aspects of the event with the journalism supervisors. They are also responsible for ensuring that participating students obtain signed parental consent/waiver forms and health certificates.
5. This Memorandum serves as the Authority to Travel of the delegation members.
6. Immediate dissemination of this Memorandum is earnestly desired.
