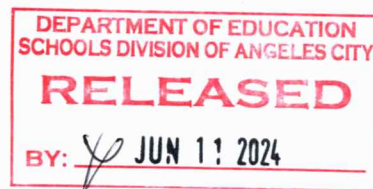

The **school health medical officer** shall ensure the health and well-being of students in **all public elementary and secondary schools in the division**, and the duties may **vary** based on the **districts, referrals** of the school health nurses, and **assistance** to the nurses in charge of **clusters 7 and 10 schools** for primary healthcare services.

4. Similarly, the **school health dentist** shall promote dental health among students in **all public elementary and secondary schools in the division** by **planning and formulating strategies for dental healthcare programs**.
