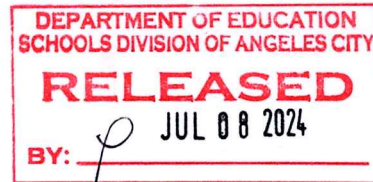

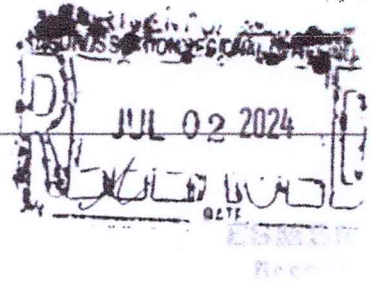

This refers to the ongoing initiative of the Government Assistance and Subsidies Service (GASS) to validate Voucher Program Beneficiaries (VPBs) under the Senior High School Program (SHSVP).

Alvarez Romales School Foundation is an SHSVP-participating school claiming the payment for 286 learners that were allegedly enrolled with their school during submission of billing statement but transferred to public schools at the time of validation.

The interview will serve as the validation if the learners have enrolled in Alvarez Ramales School Foundation. We request your good office to provide us a consolidated report either confirming or disproving the claim of the said school.





