Guidelines in the Distribution of Oral Health Bundles to Kindergarten and Grade 1 Pupils in Public Elementary Schools for School Year 2024 - 2025

- 1. Pursuant to DepEd Order 33 s, 2019 "Implementing Guidelines on the Comprehensive Oral Health Program of the Department of Education" The Colgate Palmolive Philippines, Inc (CPPI) partnered with the Department to initiate a three-year program providing Kindergarten and Grade 1 students with dental care products and educational materials. This collaboration is part of the Bright Smiles, Bright Futures Program (BSBF), which aims to enhance oral health education for children in public schools. The BSBF Oral Health Bundle for SY 2024 2025 contains a Colgate toothbrush, toothpaste, and an Oral Health and Hygiene guide for every kindergarten and grade 1 pupils.
- 2. To ensure the proper distribution of the Oral Health Bundles, the following guidelines must be strictly followed:

School Heads must:

- a. Coordinate with Division Dentist to confirm the delivery or pick-up date for the BSBF Boxes;
- b. Sign the BSBF Division Monitoring Form after receiving the BSBF Boxes;
- c. Initiate the BSBF program in your school to distribute the toothpaste and toothbrushes:
- d. After distribution, complete the SCHOOL DISTRIBUTION FORM;
- e. Teachers implementing the program are asked to provide a brief narrative report accompanied by photo documentation to monitor the program's progress; and
- f. Email the report and the BSBF School Monitoring form to bsbfphilippines@bsbfphil.com with the following details:
