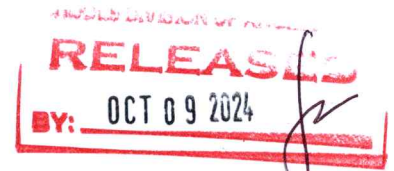

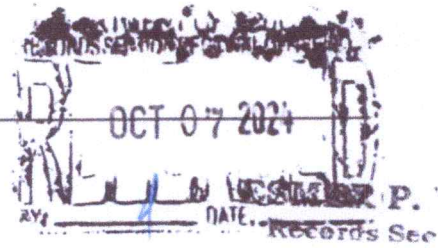

TRAINING-WORKSHOP ON THE FUNCTIONALITY OF CHILD PROTECTION COMMITTEE CUM ORIENTATION ON SAFE SPACES ACT

To : Schools Division Superintendents
Division Learner Rights and Protection Coordinators
Public and Private Elementary and Secondary School Heads
All Others Concerned

1. Anent to DepEd Order No. 40 s, 2012, all public and private elementary and secondary schools nationwide is mandated to establish a Child Protection Committee (CPC) in Schools to carry out their duties and responsibilities in protecting the welfare and rights and protection in the best interest of all learners.
2. The Learner Rights and Protection Office (LRPO) is mandated as the lead office of the Department in the establishment of Child Protection Committee and ensure its functionality in promoting and advocating of learner rights in protection in schools.
3. In line with the MATATAG agenda: **T**aking good care of learners by promoting learner well-being, inclusive education, and a positive learning environment, this Office through the Education Support Services Division (ESSD) shall conduct the Training-Workshop on the Functionality of Child Protection Committee Cum Orientation on Safe Spaces Act on October 21-25, 2024 in Clark Freeport Zone, Angeles City, Pampanga to be hosted by Schools Division Office of Angeles City. The specific venue shall be communicated ion a separate memorandum.
4. This activity aims the following:
 - 4.1 Strengthen the responsive mechanisms of DepEd Child Protection Policy including the best interests of the all learners, non-discrimination, and the right to protection from all forms abuses;
 - 4.2 Provide legal frameworks and regulations that underpin child protection policies at local, national, and international levels;
 - 4.3 Discuss the DepEd Orders relative to learner rights and protection;
 - 4.4 Provide a clear understanding of reporting processes for suspected abuse and the importance of timely and accurate referrals to relevant and competent authorities;

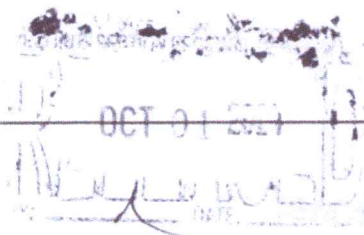
