DIVISION GUIDELINES ON THE SELECTION OF OUTSTANDING READING TEACHERS AND EFFECTIVE PROJECT LISTEN 3.0 SCHOOL IMPLEMENTER AWARDS

- 1. The Curriculum Implementation Division will be recognizing schools' and teachers' efforts, commitment, and competence in continuously developing and raising the level of reading skills of the learners through the **Outstanding Reading Teachers and Effective Project LISTEN 3.0 Implementer Awards**.
- 2. The award is open to all Public Elementary Reading Teachers and Schools with learners, who were evaluated as low emerging for Grades 1-3 and non-readers for Grades 4-6 during the Pre-Test administration of Comprehensive Rapid Literacy Assessment and Group Screening Test (GST) of the Phil-IRI and achieved the following as of March 11, 2025:
 - zero non-decoders or non-readers class;
 - 90-100% significant improvement from the 1st to 3rd Oral Reading Validation for effective Project LISTEN 3.0 school implementer award.
- 3. Preferably a teacher-awardee shall have zero drop-outs/NLPA. In case a teacher who has achieved the zero non-decoder and zero non- reader class but has dropped outs/NLPA/transferred outs, he/she may still be considered for the award if he/she has valid and evaluated supporting documents.
- 4. Teachers handling learners who are all readers from the start of the School Year 2024-2025 such as but not limited to Special Science in Elementary School (SSES) classes and Fast Learner classes are excluded from the award.
- 5. The awards to be given are the following:
 - Outstanding Reading Teacher in Filipino
 - Outstanding Reading Teacher in English
 - Outstanding Reading Teacher in Filipino and English
 - Effective Project LISTEN 3.0 School Implementer
- 4. The basis of the awards shall be the reading level obtained in the 3rd ORV administration Project LISTEN 3.0 as of *March 11, 2025* as submitted to the language supervisors.
