- 1. In compliance with DepEd Order No. 026, s. 2022, or the Implementing Guidelines on the Establishment of School Governance Council (SGC), a Provision of Technical Assistance and Pre-validation for the Implementation of School Governance Council (SGC) is scheduled on April 7-8, 2025 (Monday-Tuesday), 8:00 AM to 5:00 PM at the Gabaldon Building, Pulungbulu, Angeles City.
- 2. The objectives of this activity are the following:
  - to provide technical assistance to elementary schools in the preparation, implementation, and pre-validation of School Governance Council (SGC) documents to ensure compliance with DepEd policies and standards;
  - to assess and strengthen the functionality of SGCs in secondary schools by evaluating their sustainability practices, stakeholder engagement, and adherence to participatory governance principles; and
  - to enhance the capacity of school heads and SGC members in both elementary and secondary schools through guidance on effective governance, shared decision-making, and continuous improvement strategies for school-based management.

Participants are requested to bring their laptops, extension cords, and SGC documents for SY 2024-2025 for the hands-on activities.
