- 1. Pursuant to Republic Act No. 12028, otherwise known as the Act Establishing the Academic Recovery and Accessible Learning (ARAL) Program, and DepEd Order No. 18, s. 2025, titled "Implementing Guidelines of the Academic Recovery and Accessible Learning Program", the Schools Division Office hereby invites qualified applicants to submit their Letter of Intent to serve as ARAL Tutors in public elementary and secondary schools for School Year 2025–2026...
- 2. The ARAL Program is designed to support learners who are performing below the minimum proficiency levels in key foundational learning areas—specifically **reading** and **mathematics**. The goal is to accelerate learners' mastery of grade-level competencies through well-systematized tutorial sessions, a learner-centered approach that is supportive and empathetic of the learner's needs, motivation, and behavior. Tutors will be matched with learners based on established program criteria and learner profiles. (Please note that the Science component of the program will be implemented in the succeeding school year.)
- 3. Interested applicants are requested to submit the following documents to their respective school heads and /or through their Schools Division Superintendent on or before August 8, 2025.
 - a. Letter of Intent(to be addressed to the Schools Division Superintendent)
 - b. Updated Resume or Personal Data Sheet
 - c. Any relevant supporting documents (e.g., certifications, training records)
- 4. The eligible tutors are the following.
 - a. Teachers
 - b. Para teachers
 - c. Pre-service teachers LET eligible applicants
 - d. Retired professionals and other qualified individuals
