# DIVISION SEMINAR ON "BREAKING THE CYCLE: ADDRESSING DOMESTIC VIOLENCE FOR SAFER SCHOOLS AND WORKPLACES"

To: Assistant Schools Division Superintendent Chief Education Supervisors Public Elementary and Secondary School Heads All Others Concerned

- 1. In line with the nationwide observance of the **18-Day Campaign to End Violence Against Women (VAWC)**, the Schools Division Office of Angeles City, through the Human Resource Development (HRD) Unit, and Gender and Development (GAD) Focal Point System, will conduct a **Division Seminar on "Breaking the Cycle: Addressing Domestic Violence for Safer Schools and Workplaces" on December <b>12-13,2025** at Farm Ridge at Sierra Hotel, Pantabangan, Nueva Ecija.
- 2. The objectives of the seminar are:
   a.identify early warning signs among learners;
   b.implement proper reporting, referral, and intervention protocols;
   c.strengthen coordination with local government units and protective services;
   d.promote workplace well-being and reduce stressors that may compromise productivity; and
   e.ensure that governance decisions and operational procedures are inclusive, protective, and responsive to the needs of those at risk.
- 3. Participants are select teachers from public elementary and secondary schools and division office personnel. They are advised to wear clothing in orange color for Day 1 and DepEd T-shirt for Day 2.
- 4. A registration fee of **7,800.00** shall be collected from each participant to cover expenses for meals, accommodation, transportation and other related expenses charged to 360 **Program-under Special Programs of the Mayor's Office**, subject to auditing rules and regulations and accounting procedures.
- 5. Participants are expected to assemble between 5:30 a.m. and 6:00 a.m. Departure will be at exactly 6:00 a.m.
