1. The designation/reassignment initiative aims to promote the sharing of educational leadership and strategic management practices and to strengthen collaborative and professional relationships among internal and external stakeholders across schools and governance levels.

2. All School Principals and OIC-Principals who are designated or reassigned to another school are required to submit their respective clearances to the Personnel Unit on or before **February 4, 2026**, except those who shall remain within the same school. The official turnover of duties and responsibilities shall be conducted on **February 5, 2026**, facilitated by the Public Schools District Supervisors, in coordination with the Chief, ES-CID.

3. Teachers and non-teaching personnel of the concerned schools are hereby enjoined to extend their full cooperation and support to the newly designated or reassigned School Principals, as well as to those designated as OIC-Principals.

4. Immediate dissemination and strict compliance with this Memorandum are hereby directed.
