REASSIGNMENT OF SCHOOL PRINCIPALS, ASSISTANT SCHOOL PRINCIPAL II, AND HEAD TEACHER (BATCH 3)

To: Assistant Schools Division Superintendent

 Public Elementary and Secondary School Heads

1. Pursuant to Republic Act No. 9155, otherwise known as the *Governance of Basic Education Act of 2001*, which grants the Department of Education (DepEd), through its field offices, particularly the Regional and Schools Division Offices, the authority to manage personnel and assign teachers and school heads in support of shared governance and decentralized administration; DepEd Order No. 7, s. 2023 (*Guidelines on Recruitment, Selection, and Appointment in the Department of Education*), which emphasizes merit, fitness, and the alignment of qualifications with positions; DepEd Order No. 19, s. 2016 (*Guidelines on the Organizational Structures and Staffing Patterns of Stand-Alone and Integrated Public Schools*), which provides that school leadership should correspond to the classification and level of the school; and the Civil Service Commission (CSC) rules on personnel actions, which permit reassignment provided that it does not result in the diminution of rank, salary, or benefits and is undertaken in the interest of public service, this Office hereby announces the reassignment of School Principals, Assistant School Principal II, and Head Teacher (Batch 3) in this Division, effective July 3, 2026, as indicated below:

2. The reassignment or designation initiative aims to promote the sharing of educational leadership and effective management practices, as well as to strengthen collaboration and professional relationships among stakeholders across schools and governance levels.
3. All School Principals, Assistant Principal II, and Head Teacher who are reassigned or designated to another school are required to submit their respective clearances to the Personnel Unit on or before July 2, 2026. The official turnover of duties and responsibilities shall take place on **July 3, 2026**, to be facilitated by the concerned Public Schools District Supervisors, in coordination with the Chief, ES-CID.
4. Teachers and non-teaching personnel of the concerned schools are hereby enjoined to extend full cooperation and support to the newly designated or reassigned School Principals, as well as to those designated as OIC Principals.
5. Immediate dissemination of and strict compliance with this Memorandum are hereby directed.
